### III. CONDITIONS OF ELIGIBILITY :

1. The Scholarships will be open to Indian nationals belong to other Backward Classes as notified by the Central Govt./State Govt./UT Admn.
2. These scholarships will be given for the study of all recognised post-matriculation or post-secondary courses pursued in recognised institutions with the following exceptions.  
"Scholarships shall not be awarded for training courses like Aircraft Maintenance Engineer's Courses and Private Pilot License Courses, Courses at Training-Ship Dufferin ( Now INS Rajendra ), Courses of training at the Military College, Dehradun, courses at Pre-examination Training Centres of All India and State levels and Trade Courses at the Industrial Training Institutes."
3. Only those candidates who belong to Other Backward Classes so specified in relation to the State/Union Territory to which the applicant actually belongs, i.e. permanently settled and who have passed the Matriculation or Higher Secondary or any higher examination of a recognised University or Board of Secondary Education will be eligible.
4. O.B.C. Candidates belonging/Permanently settled in West Bengal and reading in Colleges situated within the Kolkata Corporation area and those reading in the Colleges situated outside West Bengal have to apply to their respective State Govt. through the heads of the respective Institution.
5. O.B.C. Candidates belonging to permanently settled in West Bengal and reading in the Colleges situated in the districts of Burdwan will have to Apply to P.O. Cum. D. W. O. B. C. W./Burdwan through the Head of the Institution and to submit the application to this office directly by the applicant as soon as it is filled in only to receive the Entitlement Card, in case of Durgapur/Asansol/Kalna/Katwa should have to apply in the respective Sub-Divisions B.C.W. officers/S.D.O. office.
6. The application should invariably be accompanied with the following document otherwise the application is liable to be rejected.
  - i) Xerox copy of Admit, Marksheet of the last Examination passed, duly attested.
  - ii) Admission Fee Receipt (Attested)
  - iii) Declaration of income in the annexed form 'A' (where parents are alive their income must be (declared) income means gross income including allowances other than house rent allowance if is not assessable to income tax Rental value of the house if exempted for purpose of income tax should not be taken into account for the purpose of calculating income of the parents in case of candidates whose parents own a house and have not let out any portion there of as rent. Service holders should furnish certificates from the employers showing gross monthly emoluments in other cases full details of business extent of land hold should be furnished.

- vi) Three copies of passport size photo (to be attested by the Head of the Instt./College/ Head of the Deptt.)
  - v) Hostel certificate from hostel supdtl. (In case of hostel student) with admission date of hostel duly counter signed by the head of the Institution and also by the hostel Superintendent
  - vi) Enrolment Card P.C.P for Bridge and MA/M Com. Course to be obtained from the University for correspondence courses.
6. The last date for the receipt of the application from the candidates newly admitted into the Institutions is 30 days from the date of admission to the class or joining to the class whichever is earlier.
  7. Incomplete Application and Application not received within the prescribed date are liable to be rejected.
  8. A scholarship may be cancelled if the scholar changes the course of study or the Institution without the prior approval of the authority sanctioning the scholarship.
  9. All future communications in respect of an application should be made with the P.O. Cum D.W.O B.C.W/Burdwan concerned through the Head of the Institution.
  10. All changes in address should be forthwith intimated. Candidates admitted in a recognised hostel after submission of the applications will have to submit application for hostel grant within two weeks from the date of admission to the hostel through the Head of the Institution otherwise no case is to be considered.
  11. THE HEAD OF THE INSTITUTIONS are requested to verify all the relevent informations have been duly and properly furnished and to forward the applications to the authorities stated below.

- iv) Candidates who after passing one stage of education are studying in the same stage of education in different subject e. g. I. SC after I.A. or B Com, after BA or MA in a subject after MA in another subject will not be eligible.
- v) Students who, after having completed their educational carrier in one professional line, e.g. LLB after BT/B. Ed. will not be eligible.
- vi) Students studying in Class XI of the Higher Secondary School courses or the XII class of the Multipurpose High School will not be eligible for it being a continuous school courses. However, in cases, where tenth class, examination of such courses is treated as equivalent to Matriculation and students who after passing tenth class join other courses, such student will be treated as post-matric students and will be eligible for the award of scholarships.
- vii) Students pursuing Post-graduate courses in medicine will be eligible if they are not allowed to practice during the period of their course.
- viii) Students who after failing or passing the Under Graduate/Post-Graduate examinations in Arts/Science/Commerce join any recognised professional or Technical certificate/diploma/degree courses will be awarded scholarships if otherwise eligible. No subsequent failure will be condoned except courses in Group 'A' and no further change in the course will be allowed.
- ix) Students who pursue their studies through correspondence courses will be eligible towards reimbursement of non-refundable fee. The term correspondence includes distant and continuing education.
- x) Employed students whose income combined with the income of their parents/guardians does not exceed Rs. 44,500 per annum shall be eligible for post-matric scholarships to the extent of reimbursement of all compulsorily payable non-refundable fees.
- xi) Only two children of the same parents/guardians will be entitled to receive scholarship. This restriction will, however, not apply to girls. Accordingly, scholarship availed by girls of same parents/guardians will not adversely affect admissibility of availing scholarship upto two boys of same parents/guardian.
- xii) A scholarship holder under this Scheme will not hold any other scholarship/stipend. If awarded any other scholarship/stipend, the students can exercise his/her option for either of the two scholarships/stipends, whichever is more beneficial to him/her and should inform the awarding authority through the Head of the Institution about the option made. No scholarship will be paid to the students under this Scheme from the date he/she accepts an other scholarship/stipend. The student can however, accept free lodging or a grant or ad-hoc monetary help the State Government or any other source for the purchase of books, equipments or for meeting the expenses on board and lodging in addition to the scholarship amount paid under this Scheme.
- xiii) Students who have already received coaching in any of the pre-examination training centres with financial assistance from the Government will not be eligible.
- xiv) In case of unemployed students whose parents/guardians' income from all sources does not exceed Rs. 44,500 per annum will be entitled for the scholarship under the scheme.
