**ORDER**

In pursuance of provisional sanction order and other available record a sum of Rs 60.25 lakh (Rupees Sixty lakh and twenty five thousand ) only out of the fund under MPLADS of Shri Nikhilananda Sar, Hon'ble Ex-M.P, 39- Burdwan P.C. is hereby released in favour of the Executive Agencies against schemes for immediate implementation and submission of utilisation of fund as detailed in Annexure "A" for the year 2007-08 & 2008-09.

The fund released under this order will be kept in separate interest bearing account by the implementing agency at any Nationalized Bank for avoiding mix up of the fund with other funds received from other sources.

The record of works and vouchers should be preserved by the Implementing Agency for the production before the audit from time to time as and when requires.
