ORDER

In pursuance of provisional sanction order and other available record a sum of Rs. 50.70 lakhs (Rupees Fifty lakh seventy thousand) only, out of fund under MPLADS of Shri Abu Ayes Mondal, Ex-MP, 40- Katwa P.C. is hereby released in favour of the Executive Agencies against schemes for immediate implementation and submission of utilisation of fund as detailed in "ANNEXURE -A " for the year 2008-09.

Executing Agency is hereby requested to execute the schemes in conformity with the guidelines of the GOI.

The executing agency on receipt of fund and on being satisfied that the work would be executed by following established procedure may released 50% of fund to the Head of the Educational Institution against the second scheme for the execution of the scheme .The remaining 50% of the allocation may be released on receipt of utilization certificate for the allocation from the institution.

The fund released under this order will be kept in separate interest bearing account by the implementing agency at any Nationalized Bank for avoiding mix up of the fund with other funds received from other sources.

The record of works and vouchers should be preserved by the Implementing Agency for the production before the audit from time to time as and when required.

Plaque (stone/metal) carrying inscriptions "MPLADS works with the name of MP" indicating the cost involved, the commencement, completion and inauguration date may be permanently and prominently erected at the site of works for the awareness of the local people.

Monthly progress report in respect of physical and financial performance of the schemes may also be submitted regularly to this office.
