ORDER

After careful consideration, administrative approval to the extent of the limit of fund of Rs. 7.30 lakhs (Rupees Seven lakh Thirty thousand) only as detailed in Annexure "A" is accorded herewith for speedy implementation of the works recommended by the Hon'ble M.P, Sri Abani Roy,Rajya Sabha, vide his letter No. Nil dated 26/07/2011 for the year 2010-11.

2. The executing agencies are hereby requested to prepare vetted plan and estimate of the works within the fund as recommended by the Hon'ble MP for speedy implementation of the schemes and submit requisition of fund to this office after estimation. In case where the estimated cost for execution of the works would exceed the recommended fund, MPLADS fund can be combined with funds from other sources but the use of MPLADS fund should result in completion of works and the part cost from MPLADS funds should be with reference to a clearly identifiable part of the work.

3 The requisition for fund along with vetted plan and estimate for the works in this order should be submitted by the Executing Agencies to this office within 1(one) month from the issue of this order.

4. The Executing Agency is hereby requested to execute the scheme in conformity with the guidelines of the GOI and complete the execution of the schemes within 4 (four) months of receipt of fund as per estimates for the purpose prepared.

5. The responsibility of repair and maintenance of the durable assets to be created may be taken by the organization availing the benefit. However, the executing agency is further requested to ensure the maintenance of assets to be created under MPLADS.

6. For implementation of scheme through Educational Institution a guideline issued from this office vide No 2798 (79)/DP dated 26/10/2009 should be strictly adhere to.

7. Plaque (stone/metal) carrying inscriptions "MPLADS works with the name of MP" indicating the cost involved, the commencement, completion and inauguration date may be permanently and prominently erected at the site of the works for the awareness of the local people.
